**Subject: Revised - Fiscal Year 2026 Appropriations Act**

Dear Mr. Speaker and Mr. President:

The Fiscal Year 2026 Appropriations Act represents an important effort to fund the operations of our government and provide services to our people. I commend the Legislature for its diligent effort in timely passing this appropriations bill to fund operations and prevent the risk of terminating our government health and life insurance program. The enactment of this bill, along with the passage of House Bill 24-75, secures a total of \$7.2 million towards the Group Health and Life Insurance program to ensure continuity of health coverage for more than seven thousand lives in the Commonwealth. These collaborative efforts have helped us avert a healthcare crisis and demonstrate what we can achieve when we work together.

This act also addresses priority funding areas I identified in my revised budget proposal, such as mandatory obligations of the Department of Corrections and sufficient funding levels for the Health Network Program. However, major budget cuts were made to the Marianas Visitors Authority (MVA), needed for tourism recovery, and to the CNMI Public School System.

**Public School System**

Approving this measure brings the Public School System funding to \$36.2 million, still \$1.5 million below my proposal. I strongly urge the legislature to act on H.B. 24-70 to increase funding to PSS by \$4.9 million, which would provide a consolidated funding level of \$41.1 million. I encourage the Public School System to prioritize bringing our students back into the classroom.

### **Tourism Recovery**

I share the sentiments of MVA and express deep disappointment and concern about the reduction in funds, leaving MVA with a meager budget of \$3.5 million. Tourism is not a discretionary program for the Commonwealth, it is a core economic engine that supports thousands of local jobs, small businesses, airlines, hotels, and government revenues. At a time when our visitor economy is still in recovery, these cuts directly weaken our ability to rebuild demand, support air service, and compete in regional markets. Funding to MVA fills seats, hotel rooms, and restaurants. Reducing these funds will slow our recovery, undermine progress, and make it harder to stabilize and grow our tourism economy. I urge consideration for increased funding in the next budget cycle to support tourism recovery.

## **COMMENTS ON APPROVED PARTS OF THE ACT**

### **Section 403. Donation of Sick Leave.**

There may be a disparity in pay rates between the donor and the recipient of donated sick leave hours. The provision allows donated sick leave at a value of 1.0; this may require additional donated sick leave hours when the recipient's rate is greater than the donor's, increasing the government's fiscal obligations. The Civil Service Commission can amend the regulations to address this issue.

Alternatively, legislative action could provide for donated sick leave hours to be valued at a maximum of \$15 per hour. Recipients of donated sick leave would be compensated at no more than this capped rate per hour, and in no case would the payment exceed the recipient's current hourly wage.

### **Section 501. Reprogramming Authority.**

Section 501(c) grants 50% reprogramming authority to the mayors of each Senatorial District. This authority should be wielded over local funds to ensure efficiency in local government and not over executive branch departments.

### **Section 607. Legal Holidays.**

In implementing this provision, care should be taken to avoid conflict with the federal Fair Labor Standards Act (FLSA).

### **Section 614. MVA Trust Funds.**

This section requires the Secretary of Finance to allocate a minimum of \$43,750 per quarter to the municipalities and no less than \$175,000 before the end of the fiscal year. This provision may result in less direct funding to the Marianas Visitors Authority to mitigate impacts of declining tourist arrivals should the actual collection of the Hotel Occupancy Tax be less than the required transfer. Any shortage of collections would divert funds from MVA to the municipalities.

### **Section 616. Payment of 25% to Retirees.**

I observe that what the Settlement Agreement requires of the CNMI government is to annually make payments to the Settlement Fund sufficient to enable the Settlement Fund to pay 75% of settlement class members' full benefits.

**Section 702. Appropriation.**

The identified excess appropriation of \$4,426,099 in this provision, relative to projected revenues in the budget proposal, will be resolved through the exercise of administrative authority. Expenditure levels will be adjusted downward from \$138,935,827 to \$134,509,728, thereby ensuring that appropriations are aligned with revenues and the budget remains balanced.

**Section 704. Legislative Branch.**

I understand the reference to “[a]ll appropriations by the Commonwealth” in Section 704(k) to mean appropriations to the Legislature.

I am approving this provision to establish a separate Legislature Operations Fund.

However, establishing such a Fund without first implementing adequate financial systems poses serious risks. Without these systems, payroll and contract management will be disrupted, potentially causing a shutdown of legislative operations.

I strongly encourage the Legislature to take meaningful steps to plan this major transition and ensure the systems required for operational independence are properly established. The lack of necessary systems will prevent the Secretary of Finance from making any legislative payments to comply with this act.

**Section 709. Other Programs.**

Section 709(c) provides for 96% of funding to the Public School System to be directed towards instructional expenditures and restrictions on austerity measures. My administration encourages further dialogue with PSS to ensure that legislative provisions are aligned with students’ needs and operational necessities.

**Section 711. Department of Public Lands.**

The Memorandum of Understanding to be executed by the Department of Public Lands, the Department of Lands & Natural Resources, and the mayors of the municipalities should ensure a nexus to the constitutional responsibilities of DPL in maintaining and securing public lands and properties.

The remittance to the Marianas Public Land Trust mandated by Section 711(c) has already been consummated.

**VETOED PARTS OF THE ACT**

I have reviewed this measure with the Attorney General and found that certain provisions of this measure may conflict with constitutional requirements, established fiscal management laws, or practical realities of implementation.

To ensure that appropriations are lawful and sustainable, preserve constitutional integrity, uphold fiscal discipline, and protect the financial stability of the Commonwealth, I am exercising my authority pursuant to Article II, Section 7 of the NMI Constitution to line-item-veto certain provisions of this measure.

**Section 201. Estimated Revenues.**

The inclusion of a \$4,426,099 "General Fund Prospective Adjustment" without an identified revenue source is unconstitutional. This provision violates Article III, Section 9(a) of the NMI Constitution, which provides that "[t]he anticipated revenues may not be increased by the legislature without the consent of the governor." This measure appropriates funds that have not been identified in my proposed annual budget, undermining fiscal discipline and exposing the Commonwealth to legal challenge. I therefore respectfully disapprove this unknown revenue source.

**Section 203. Reporting Requirements for Secretary of Finance.**

Section 203(d) is duplicative of reporting requirements in the Planning and Budgeting Act. I am vetoing Section 203(e), as it presents a constitutional separation of powers issue by stipulating adverse personnel actions for an Executive Branch officer.

**Section 602. Hiring Restriction.**

I have disapproved Section 602(a) because it violates the separation of powers for the Legislature to determine via joint resolution, on a case-by-case basis, whether budgeted executive branch positions are essential for delivery of public services. Implementation of this provision will be problematic as it restricts the Executive Branch's ability to respond to operational needs.

I have also disapproved Section 602(b), because it is unenforceable for a Notice of Personnel Action to be deemed processed without adequate funding or authorized positions.

**Section 603. Salary Cap.**

Section 603(a) is hereby disapproved as compensation for appointed officials is already stipulated under 1 CMC § 8425 and unnecessary in this measure. This provision freezes appointed officials' salaries at the level of my budget submission and requires legislative approval for adjustments. It conflicts with Section 603(e), which permits use of federal and non-General Revenue funds to support salaries above statutory caps. Vetoing Section 603(a) resolves this conflict and preserves executive authority.

**Section 604. Salary Increases after Revised Budget Submittal.**

Section 604 retroactively reverses salary increases, impairing valid contracts and undermining employee trust. Fiscal discipline must be achieved prospectively, not through retroactive measures that destabilize operations. Accordingly, Section 604 is hereby disapproved to avoid legal challenges, preserve contractual integrity, and maintain confidence in the government's employment practices.

**Section 609. Vacant Positions.**

I have disapproved this section as it provides that any position that becomes vacant shall be closed out. Implementation of this provision places an inflexible constraint on the Executive Branch's ability to respond to operational needs.

**Section 612. Hazardous Pay.**

A portion of this section is disapproved to allow the Secretary of Public Works to process hazardous pay based on funding availability and ensure that payment requests meet necessary requirements.

**Section 617. Outside-Sourced Revenue Received by the CNMI.**

This provision purported to mandate that “[a]ny funds received by the CNMI government from the federal government or other outside sources shall be identified by the Governor and reported to the Legislature for appropriation.”

This provision would violate federal law, as federal grants to instrumentalities of the CNMI government must be used for the cost objectives stipulated in the terms of the grants.

Item 4 of Section 617 seeks to redirect federal funds, including those from the Office of Insular Affairs. These funds are restricted by grant terms and cannot be reappropriated by the Legislature, rendering this portion unenforceable. Therefore, I disapprove this section.

**Section 703. Judicial Branch.**

I have disapproved Section 703(d) because the Judicial Branch, like the rest of the CNMI government, may be subject to proportional cuts as provided by the Planning and Budgeting Act, 1 CMC § 7204(e). Absent a new budget, this provision prohibits the Governor from exercising fiscal discipline through proportionate reduction to all branches of government should there be a revenue shortfall. Vetoing this provision preserves historical best practices and ensures statutory tools are available for efficient fiscal management.

I acknowledge the desire for prospective proportionate cuts, if necessary, and will ensure future budgetary adjustments will result in a balanced budget.

**Section 704. Legislative Branch.**

I have disapproved Section 704(j) on the same grounds as Section 703(d) because the Legislative Branch, like the rest of the CNMI government, may be subject to proportional cuts as provided by the Planning and Budgeting Act, 1 CMC § 7204(e).

Several provisions in Section 704(k) are unconstitutional and are therefore disapproved. Any given annual appropriation bill cannot govern amounts appropriated by the Legislature in future annual appropriation bills. Expenditure of funds appropriated to the Legislature cannot be exempted from the public purpose requirement under Article X, Section 1 of the NMI Constitution or from the Department of Finance’s oversight under Article X, Section 8.

**Section 705. Executive Branch.**

Section 705(d) provides that the Department of Community and Cultural Affairs, alone among CNMI executive agencies, is to retain indirect costs of federal grants which would otherwise be statutorily earmarked to the Office of Grants Management. There is no sound reason to treat DCCA differently from all other agencies in this respect. I have disapproved this section.

I have disapproved Section 705(f) because this provision unduly restricts the discretion of the Department of Labor to allocate its resources to workforce training programs as appropriate. I urge the Secretary of Labor to include the municipalities’ apprenticeship and training needs in the proposed expenditure plan for the Commonwealth Worker Fee Fund.

**Section 705.1. Limitations on 1 CMC 7604 and 7204 Austerity Provisions & Prohibition on Retroactivity.**

As stated above in Section 703, absent a new budget, this provision prohibits the Governor from exercising fiscal discipline through proportionate reduction to all branches of government should there be a revenue shortfall.

Accordingly, Section 705.1 is hereby disapproved to preserve the enforcement mechanism established under §§ 7204 and 7604 of the Planning and Budgeting Act, which is essential to ensure statutory tools are available for efficient fiscal management.

**Section 708. Third Senatorial District- Mayor of Saipan; Mayor of the Northern Islands; and Saipan and Northern Islands Municipal Council.**

Section 708(b) is disapproved because authorizing the Mayor of the Northern Islands to promulgate regulations to generate revenues from fees is an appropriate subject for SNILD legislation, not the annual appropriations bill.

**Section 709. Other Programs.**

I have disapproved the requirement in subsection (e) that the CNMI Health Network Program, formerly known as the Medical Referral Program, shall include stipends, airfare, and lodging for patients and escorts in the inter-island medical referral services. The appropriation for the Health Network Program is insufficient to cover such costs. This is an unfunded mandate.

**Section 711. Department of Public Lands.**

I have disapproved a portion of Section 711(a) which notes that the Department of Public Lands submitted a budget of \$4,892,548. This figure does not match the revenues identified in Section 201 of the Act at \$4,439,007. Appropriations must align with certified revenues, and the higher figure would create a budgetary imbalance.

I have also disapproved another portion of Section 711(a) because ground maintenance and landscaping work under the jurisdiction of Parks and Recreation is a statutory responsibility of the Department of Lands and Natural Resources.

**Section 712. Financial Data and Transparency Information Access.**

I am disapproving Section 712's provisions because they are duplicative of the reporting requirements set forth in Section 203 and create additional and unreasonable administrative burdens that will be difficult to implement.

That said, I appreciate the Legislature's desire for transparency, improved access to accurate data, and timely reporting. I am therefore directing the Secretary of Finance to work with the Legislature to develop appropriate protocols for expanding the Legislature's access to MUNIS, ensuring quality control for reports generated from MUNIS, and training the staff of the Legislative Branch in using and navigating MUNIS to obtain financial data in the format the Legislature requires in order to perform its own analyses.

### **Section 713. Violation of Spending Limits.**

I have disapproved the additional penalties and sanctions in Section 713. The Planning and Budgeting Act (PBA), as amended, has adequate enforcement provisions to assure compliance with the expenditure restrictions under the PBA and this Act.

In particular, 1 CMC §§ 7701 and 7702 provide criminal penalties for expenditures in excess of authorization by law.

### **Section 802. Non-General Revenue Sources.**

I have disapproved parts of Subsection (b) because of inconsistency between the language and U.S. Public Law 115-218, which governs the use and administration of the CW funds. The federal law does not limit training programs to only those for vocational training. The federal law also provides restrictions on the administration of the funds, including reprogramming and fiscal year limitation.

### **Schedule A.**

While I recognize the importance of soil and water conservation efforts across the Commonwealth, I must disapprove the establishment and funding allocation for CNMI State Soil and Water Conservation Districts, Inc., included under the Independent Program heading.

The Act does not contain any express provision clarifying the intent behind its inclusion. Moreover, the program is already embedded within all three senatorial districts, and the creation of a centralized office would be duplicative and administratively redundant.

I remain committed to supporting conservation initiatives through existing district-level programs and encourage continued collaboration to ensure resources are used efficiently and effectively.

### **Conclusion**

These line-item vetoes are a necessary step toward building a stronger, more resilient future for our Commonwealth. By upholding constitutional principles, ensuring fiscal responsibility, and protecting the separation of powers, we lay the foundation for lasting stability and progress.

My commitment to working hand in hand with the Legislature is unwavering. Together, we have an opportunity to turn these challenges into solutions that strengthen our financial health and improve the effectiveness of government. Let us move forward with purpose and unity to create a government that is not only accountable, but visionary—one that delivers for our people today and for generations to come.

Lt. Governor and I wish you and your families a joyful Christmas.

This measure becomes **Public Law 24-20**.
